THE PUBLIC TAX SALE WILL BE HELD AT THE COURTHOUSE- 106 S 5TH ST. PENDER, NE 68047.

THE DATE OF THE PUBLIC TAX SALE IS MONDAY MARCH 2, 2026.

THE REGISTRATION DEADLINE TO ATTEND THE SALE IS FRIDAY FEBRUARY 27, 2026.

THE REGISTRATION FEE IS \$25.00 PAYABLE TO THE THURSTON COUNTY TREASURER.

EACH PUBLIC TAX SALE CERTIFICATE FEE IS \$25.00.

THE DELINQUENT TAXES ADVERTISED DO NOT INCLUDE INTEREST AND ADVERTISING FEES.

THE MINIMUM AGE TO BID IS 18.

THE CHECK-IN TIME BEGINS AT 8:30 AM IN THE TREASURER'S OFFICE.

THE SALE WILL BEGIN AT 9:00 AM AND END WHEN THE BIDDERS ARE FINISHED PURCHASING.

THE DELINQUENT TAX LIST IS PUBLISHED ON OUR WEBSITE www.thurstoncountyne.gov AND THE PENDER TIMES NEWSPAPER PH. 402-385-3013.

THE SALE WILL BE CONDUCTED IN A (ROUND ROBIN) FORMAT.

EACH BIDDER WILL CHOOSE 1 PARCEL EACH TURN ANNOUNCING THE TAX DISTRICT AND PARCEL NUMBER THAT COINCIDES WITH THE PROPERTY.

THURSTON COUNTY HAD 5 ACTIVE BIDDERS AT THE 2025 PUBLIC TAX SALE.

PROPERTY TAX DELINQUENT DATES 2026

THE 1ST HALF OF 2025 TAXES BECOME DELINQUENT MAY 1, 2026. FOR THOSE WHO WISH TO PAY THEIR TAXES BY MAIL, POSTMARKED DATES WILL BE HONORED UP TO APRIL 30, 2026. INTEREST WILL BE CHARGED IN OUR OFFICE AT A RATE OF 14% BEGINNING MAY 1, 2026. THE 2ND HALF OF 2025 TAXES BECOME DELINQUENT SEPTEMBER 1, 2026. A POSTMARK UP TO AUGUST 31, 2026 WILL BE HONORED. INTEREST ON THE 2ND HALF WILL BE CHARGED IN OUR OFFICE AT A RATE OF 14% BEGINNING SEPTEMBER 1, 2026.

*A DROP BOX IS LOCATED IN THE ALLEY OF THE COURTHOUSE FOR ANYONE WISHING TO DROP OFF TAX PAYMENTS. INTEREST CHARGES BEGIN ON MAY 1, 2026 AND ON SEPTEMBER 1, 2026 WHEN DROPPING OFF TAX PAYMENTS.
